

## MSW Frequently Asked Questions

### 1. What programs do you offer and how long is the program?

A: We offer Three (3) Options for the MSW programs:

- I. The 11-month MSW Advanced Standing Program (ASP) is only for qualified applicants with a BASW degree.
- II. The Full-time Two (2) year program and
- III. The Three Year (3) year program.

The Two (2) year program is a four-semester, 60-semester unit program which includes internship. Classes are held all day on Tuesdays and Thursdays and require 16 hours per week of internship in the first year and 20 hours per week in the second year.

The Three (3) year program is a six-semester, 60-semester unit program, including internship. Classes for the 3-year program are held one evening a week, usually Tuesdays and all-day Saturdays. The internship starts in the second year of the program and requires 16 hours per week. The last year (year 3) requires 20 hours per week.

The ASP program is offered at the Downtown Los Angeles (DTLA) campus and is an 11-month, 33-semester unit program (3 semesters) including internship. Classes are held on Mondays and Tuesdays all day (fall and spring semesters) and the internship is completed Wednesdays, Thursdays, and Fridays for a total of 24 hours per week. Summer semester classes are three days per week for four weeks.

### 2. Is the program accredited?

A: Yes, our MSW program has been accredited since 1999 by the Council on Social Work Education [https://www.cswe.org/accreditation/directory/?pg=&program\\_state=CA&program\\_level=Master%27s](https://www.cswe.org/accreditation/directory/?pg=&program_state=CA&program_level=Master%27s).

### 3. What is the cost of the program?

A: The costs listed below are approximate and reflect the current academic year. Tuition is subject to change upon approval of the Board of Trustees.

The cost of the Advanced Standing Program (ASP) is \$17,325.00,

The cost of the Two (2) year program is \$17,364.00, and

The cost of the Three (3) year program is \$26,046.00.

### 4. Do I need to have a degree in Social Work to apply to the 2-year or 3-year MSW program?

A: As long as you have a bachelor's degree from an accredited college or university and satisfy the three prerequisites you may apply to the MSW program. Please note, that your degree must be conferred for you to begin a graduate program. You will need to submit official transcripts to the Office of Enrollment Services to verify that your bachelor's degree has been conferred.

### 5. What is the minimum GPA?

A: The minimum GPA requirement for the Two (2) year and Three (3) year programs is 2.75, in the last 60 semester units or 90 quarter units.

For the ASP program, the GPA requirement is 3.0 cumulative.

### 6. What are the academic prerequisites required for admissions?

A: There are three (3) prerequisites for the Two-year and Three-year programs that must be passed with a "C" grade or better. The prerequisites are research methods and statistics, which can be met

with any elementary or introductory statistics course. The remaining two prerequisites are two (2) upper-division social science courses. Upper-division refers to junior and senior-level classes. CSULB has an extensive list of approved statistics courses, please click the link below to see if the course you took is listed there.

If the course you took is not included on the posted list, you may submit a course description and syllabus to the admissions coordinator ([mswadmissions@calstatela.edu](mailto:mswadmissions@calstatela.edu)) to find out if it satisfies the requirement.

There are no prerequisites for the ASP program as all prerequisites are met with the required BSW degree.

**7. Do I need to have completed all the requirements and/or prerequisites before applying for the MSW program?**

A: Applicants need to have 2 of the 3 prerequisites completed at the time their application is submitted. Please note, that all requirements and/or prerequisites must be completed before starting in the program.

**8. Do I need to take the Graduate Record Exam (GRE)?**

A: No, the GRE is not required.

**9. Do you have an online MSW program?**

A: No, we do not have an online program.

**10. Do you offer tracks or concentration?**

A: No, Cal State LA, School of Social Work no longer offers concentrations. We have an advanced urban generalist focus that prepares students to provide service across the spectrum of practice. Capitalizing on CSLA's location, this focus offers students an opportunity to learn effective and responsive strategies for working in any urban environment at the micro (individual/family), mezzo (group/community), and macro (policy/societal) levels.

**11. When is the deadline for admission?**

A: The deadline for application submission is January 15, 2025, for the traditional 2-year and 3-year programs. The filing period for the ASP program is February 1 to 28, 2025, with the deadline being February 28, 2025.

Applicants are accepted on a rolling admissions basis, which means applications will be reviewed on a first-come, first-served basis until spaces are filled. Please note that your application must be complete, and all required documents must be submitted and received by the application deadline of January 15, 2025, or February 28, 2025, for the ASP program to be reviewed for admission.

**12. Can I apply in the Spring or Summer semester?**

A: No, we admit students only once per year. The traditional 2 and 3- year MSW program admits students only for the Fall semester and, Summer semester matriculation for ASP only.

**13. How many recommendations do I need? Do I need an academic and a professional reference?**

A: Yes, three (3) references are required to apply to the MSW program. For the Two (2) year and Three (3) year programs, one reference must be from an academic source (i.e., a professor or

instructor), and one reference must be from a professional source (i.e., a supervisor in a volunteer or paid position), and the third reference can be either an academic or professional source. **Personal references are not appropriate and will not be accepted.** Examples of a personal reference include a family friend, therapist, pastor, or coworker.

Please note, that if you graduated more than eight years ago, you could submit a professional reference in place of an academic reference. However, you must provide a brief explanation as to why you were unable to submit an academic reference. Regarding your references please be aware that you will be submitting the names and email addresses of the people who will be completing the reference form. Once you submit their names, they will be emailed the reference form to complete.

For the ASP program, you need three references: one academic, one from your integrated seminar instructor, and one from your internship instructor.

If you or your reference are having problems with your reference, please contact the application helpline at 857-304-2087. Please note that they work on eastern standard time.

**14. What is the deadline to apply to the university?**

A: The university application deadline for the Two (2) year and Three (3) year programs is January 15, 2025. The ASP university deadline is February 28, 2025. Please note that the ASP program begins summer semester and is only offered at the Downtown Los Angeles (DTLA) campus.

**15. Can I apply to the ASP and either the Two (2) year or Three (3) year program?**

A: Yes, however, you will be applying for two separate start terms and campuses. The ASP program begins in the summer semester, and classes are held at the DTLA campus. The Two (2) year and Three (3) year programs begin in the fall, and classes are offered at the main campus.

**16. Do you offer Financial Aid, Stipends, or Grants?**

A: Yes, our program offers seven stipends for students with specific interests. More information is available at <https://www.calstatela.edu/hhs/sw/stipend-programs> . ***Please be aware that you must first be admitted to the MSW program to apply for a stipend.***

- I. The California Title IV-E Education Program (formerly CalSWEC) stipend is for students with an interest in Public Child Welfare. A two-year stipend of \$25,000 each year is available to students in the 2 and 3-year program and requires a two-year commitment to work for a county public child welfare agency anywhere in the state of California after graduation. CA Title IV-E is also available to County Public Child Welfare employees in the 3-year program with reimbursement for tuition and fees, books, educational expenses, and mileage. Stipends may be available to BASW students, depending upon availability of funding. BASW stipend recipients commit to a minimum of one year of public child welfare employment after graduation.
- II. Los Angeles County Title IV-E DCFS Internship Program is open to all options Two (2) year, three (3) year and ASP students who are interested in Public Child Welfare. The stipend provides \$26,000 and requires a two-year commitment to work for LA DCFS.
- III. Los Angeles County Department of Mental Health stipend is a one-year stipend, available to students in their final year of the MSW program. It is open to all options (ASP, 2-YR, & 3-YR) MSW students

who will graduate by May or August, the stipend amount is \$18,500. Students awarded a stipend will need to commit to one-year (12 consecutive months) of employment post-degree in a clinical capacity at either a directly operated or agency contracted by LAC DMH. This stipend program is administered and managed by Phillips' California Stipend Program of Campbellsville University at the Los Angeles Education Center (CULAEC). For AY '24-'25 the LAC DMH stipend online application will be available starting Wednesday, December 18 through Wednesday, February 12, 2025.

- IV. The Geriatric Social Work (GSWEC) Stipend is open to both Two (2) year and Three (3) year MSW program students in their final year of the program. This is a one-year stipend, only available to students in the last year of the MSW program. To qualify, students must complete an application and be selected by a GSWEC-approved agency for their 2<sup>nd</sup> yr. internship. Stipend amounts range from \$4,000 to \$6,000.
- V. Health Care Access and Information (HCAI) fellowship is for students interested in working with behavioral and mental health. Selected fellows will be awarded with the stipend amount of \$10,000 per academic year. The program is for Full-time (2-YR) and Advanced Standing Program (1-YR) students who are committed to working in behavioral health fields serving underserved/unserved communities, focusing on children and youth through age up to 25 years old and their caregivers.
- VI. Public Behavioral Health (CalSWEC- PBH) Stipend recipients receive funding of up to \$25,000 per training year and will commit to providing the equivalent of 12 months of full-time service in publicly funded behavioral health programs and settings in the state of California after graduation. PBH is open to eligible students enrolled in MSW programs in all options (2 yr., 3 yr., or ASP) who are in publicly funded behavioral health practicum placements.
- VII. The Adult Protective Services - California Social Work Education Center (APS-CalSWEC) program is for those interested in working with the elderly. It focuses on specialized field intended to enhance understanding of the needs of this vulnerable population and the agencies that serve it. Each MSW student participant will be awarded a \$20,000 stipend. This program is open to eligible students in all three options of our MSW program (2 yr., 3 yr., or ASP) who are in placements serving older adults. Each stipend program has its own set of criteria, the application process, and terms associated with the stipend award. Stipends are competitive and require a separate application and an interview.

**17. Do I need a car and valid auto insurance to enroll in the MSW program?**

A: A car is not required; however, students are expected to spend between 16-24 hours a week in a community-based fieldwork agency. Many agencies will require that student interns have a car and valid driver's license, and auto insurance. Please note: There is no guarantee that your placement will be near your home. If a student does not have reliable transportation, this may impede the field placement process, and that will limit where they are placed.

**18. I have a misdemeanor and/or felony on my record. Can I still apply?**

A: Yes, you may apply. Be aware, that if you do not successfully match with an internship agency after three (3) attempts, your MSW acceptance may be rescinded. Applicants should be mindful that they are required to pass a Live Scan and/or complete a background check. If you have ever been arrested or convicted of a crime (e.g., misdemeanor and/or felony) please consider getting your record

expunged before applying to the MSW program, as it may preclude you from entering a field internship.

There are certain practicum and professional social work settings that will not allow persons on-site if they have certain misdemeanors or felonies in their background. Students should consult with the Practicum Director immediately with concerns about their ability to be placed with an agency, or their future employability in the social work field.

**19. What is considered Social Work experience?**

A: Experience in working in the social work field, case management, health, and human services, and/or has been supervised by a credentialed social worker (B.S.W., M.S.W., L.C.S.W., Ph.D., or D.S.W.).

**20. Does CSLA have services available for veterans?**

The MSW program does not waive the TOEFL **MSW Program does not waive the TOEFL**. Cal State LA requires a foreign credential evaluation report for advisory purposes. To satisfy this requirement, international graduate applicants must submit their non-US academic records/transcripts to the International Education Research Foundation (IERF) or World Education Services (WES) for international credential evaluation. (Be aware, beginning with the Fall 2024 admission term, we will also accept reports from NACES member agencies when accompanied by official transcripts.)
